- Full-resolution digital JPG files available on DVD disc at a rate of \$110 for each 20 image files (only images selected by photographer are available). These will include full print release.

Policies and Terms

A. A retainer of 1/2 of hourly coverage or total of ala carte to reserve the wedding day, and a second & third deposit equal to 1/4 of the hourly coverage or total of ala carte due 60 & 14 days prior to wedding date.

B. A Wedding Coverage preference must be chosen at time of signing the contract.

C. Images on DVD will be ready 2 to 3 weeks after the wedding.

D. Payment in full due at time of placing complete wedding order if albums and extras are ordered.

E. Cancellation less than 260 days prior to the wedding will cause a forfeiture of the original retainer.
